



# A national survey of 1,000 Registered "Likely" Voters






Do you feel things in the country are going in the right direction, or do you feel things have gotten off on the wrong track?






Do you feel things in the country are going in the right direction, or do you feel things have gotten off on the wrong track?






If the election for President were being held today, and you had to make a choice, would you be voting for the Republican candidate or President Barack Obama, the Democratic candidate?






If the election for Congress were being held today, and you had to make a choice, would you be voting for the Republican candidate or the Democratic candidate, in your Congressional district?





If the election for Congress were being held today, and you had to make a choice, would you be voting for, the Republican candidate or the Democratic candidate, in your Congressional district?







# After the 2012 elections, do you believe that the Democratic Party will continue to be the majority party in the US Senate?








## And what would you say is the next most important problem? (If choice made in Q5, Asked of N=936, or 93.6% of Sample)






# How would you rate the job Barack Obama has been doing as President? Do you approve or disapprove of the job he is doing?










# How would you rate the job Congress is doing? Do you approve or disapprove of the job they are doing?






# Do you think you will vote to re-elect Barack Obama, will you consider voting for someone else, or do you think you will vote to replace him?





If the Presidential election were held today and you had to make a choice, for whom would you vote, Mitt Romney, the Republican, or Barack Obama, the Democrat?


















Whether you approve or disapprove of the way Barack Obama is handling his job as President, what is your impression of Barack Obama as a person? Do you approve or disapprove of him?






# What is your impression of Mitt Romney as a person? Do you approve or disapprove of him?






# Do you believe that President Obama's economic policies have -helped make the economy better, had no impact on the economy, or made the economy worse?









### Help pay down the debt and deficit to create a pro-growth economic environment OR Increase spending on job creation?




If the tax increase were to go into effect, which do you believe President Obama *would* actually do - use the additional money raised from the tax increase to:
