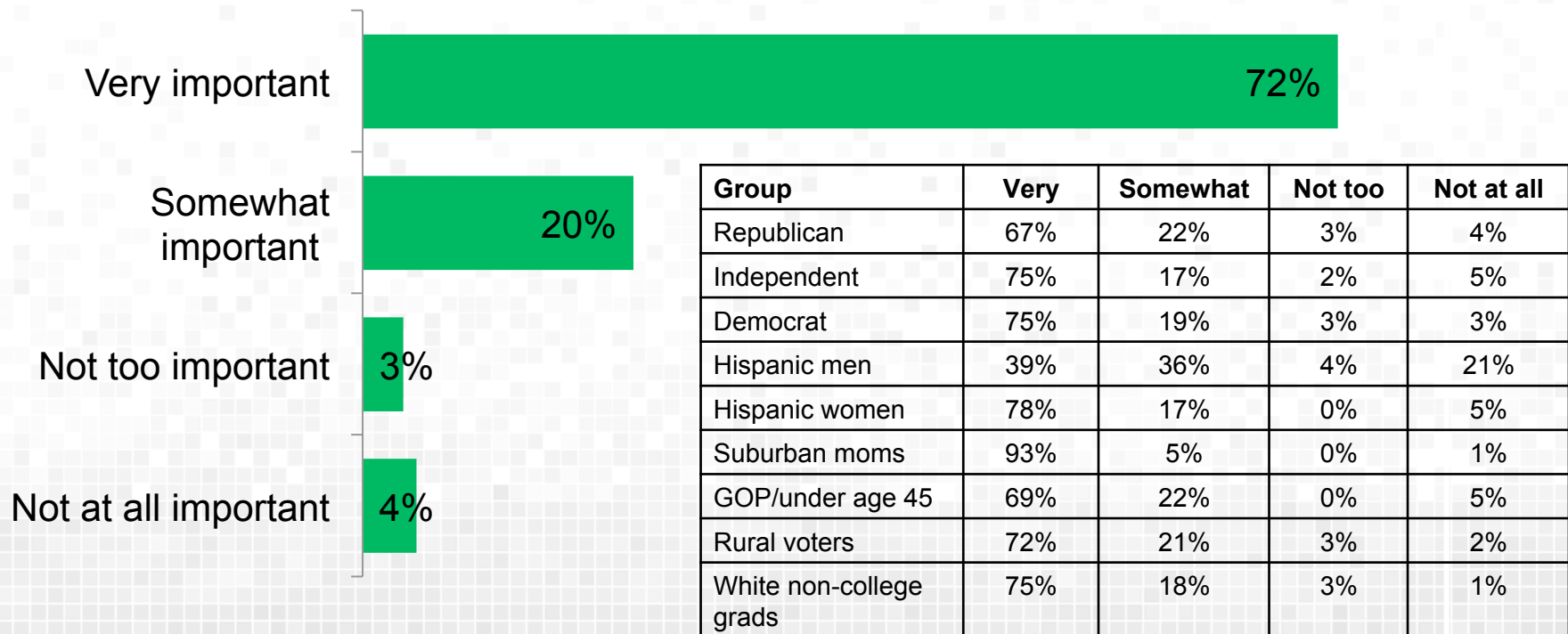

Survey Methodology

- This bipartisan poll was designed and administered by The Tarrance Group in collaboration with Lake Research Partners.
- The survey was conducted via live telephone interviews between December 3-8, 2022
- The survey reached a total of N=800 voters nationwide.
- Quotas on age, region, gender, and number of interviews conducted via cell phone were used to ensure a representative sample.
- The margin of error for this sample is +/-3.5%.

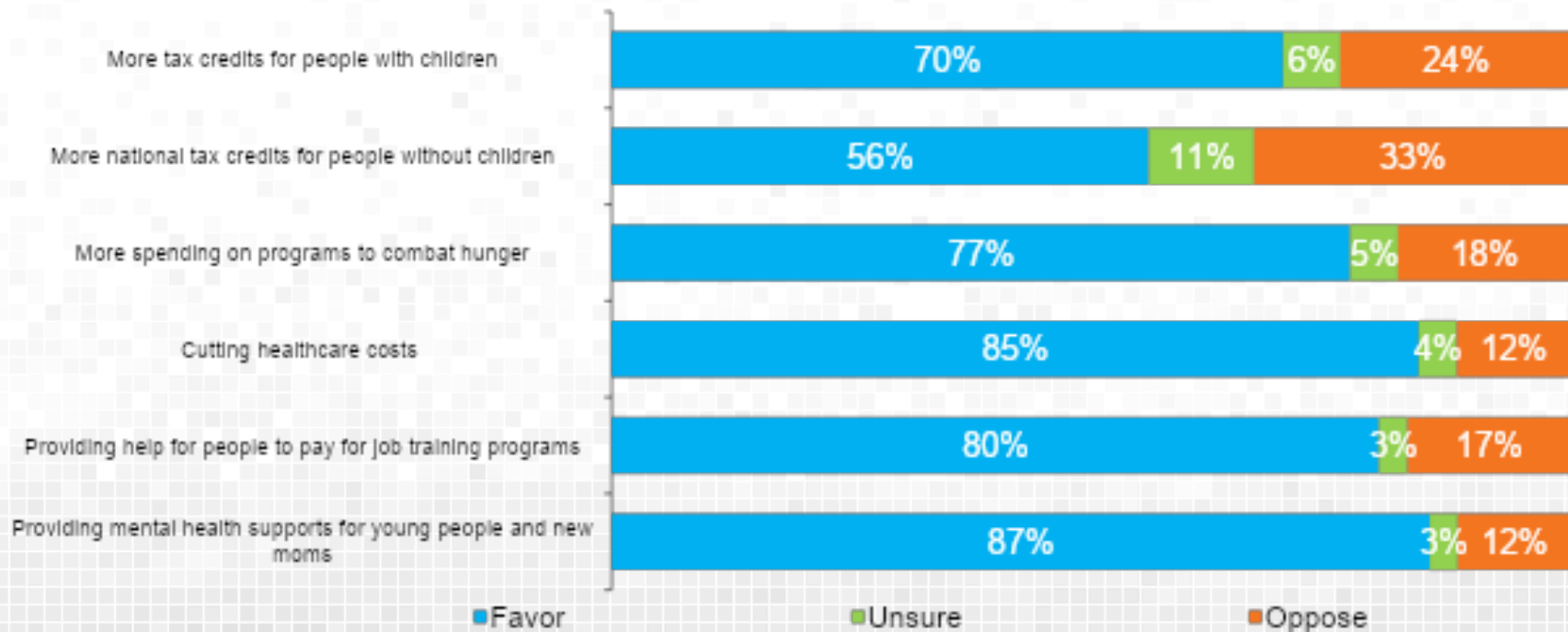
Getting Things Done ...

Thinking about the specific problems working families face, how important is it that elected officials are willing to make compromises with officials from the other political party to get something done?



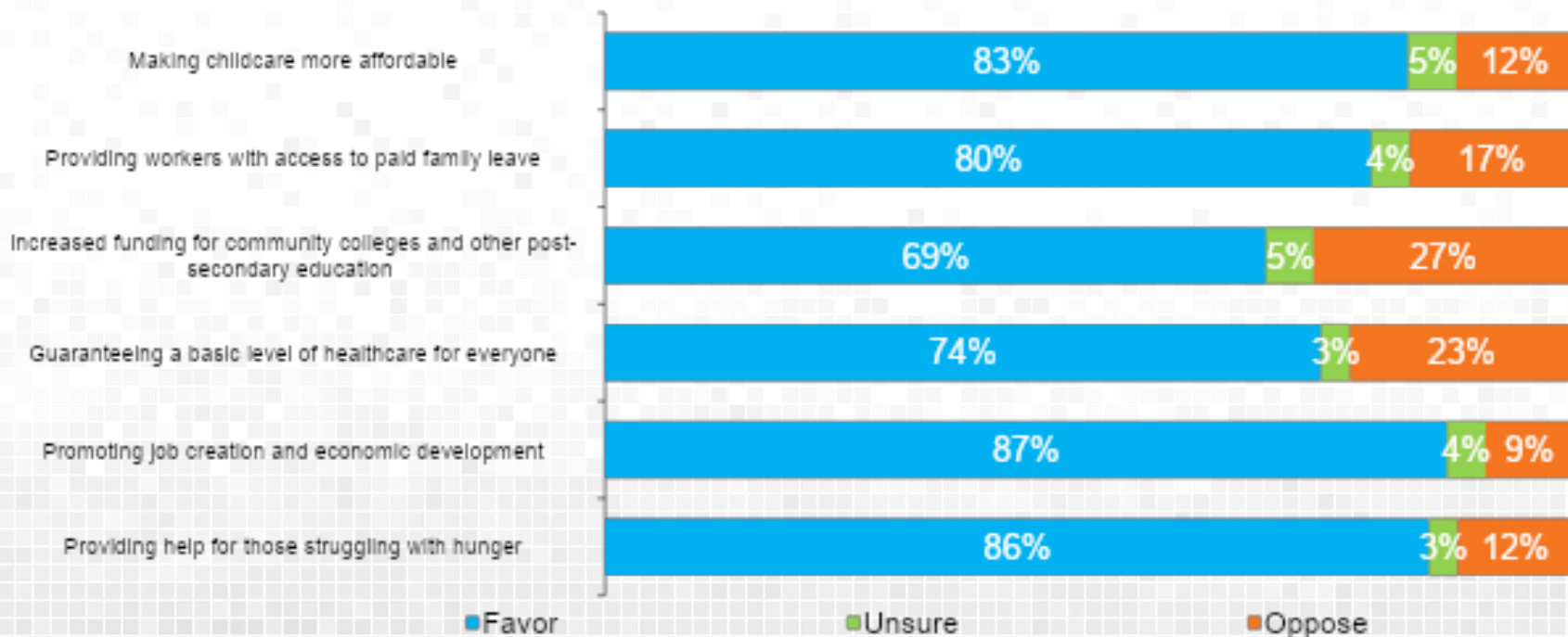

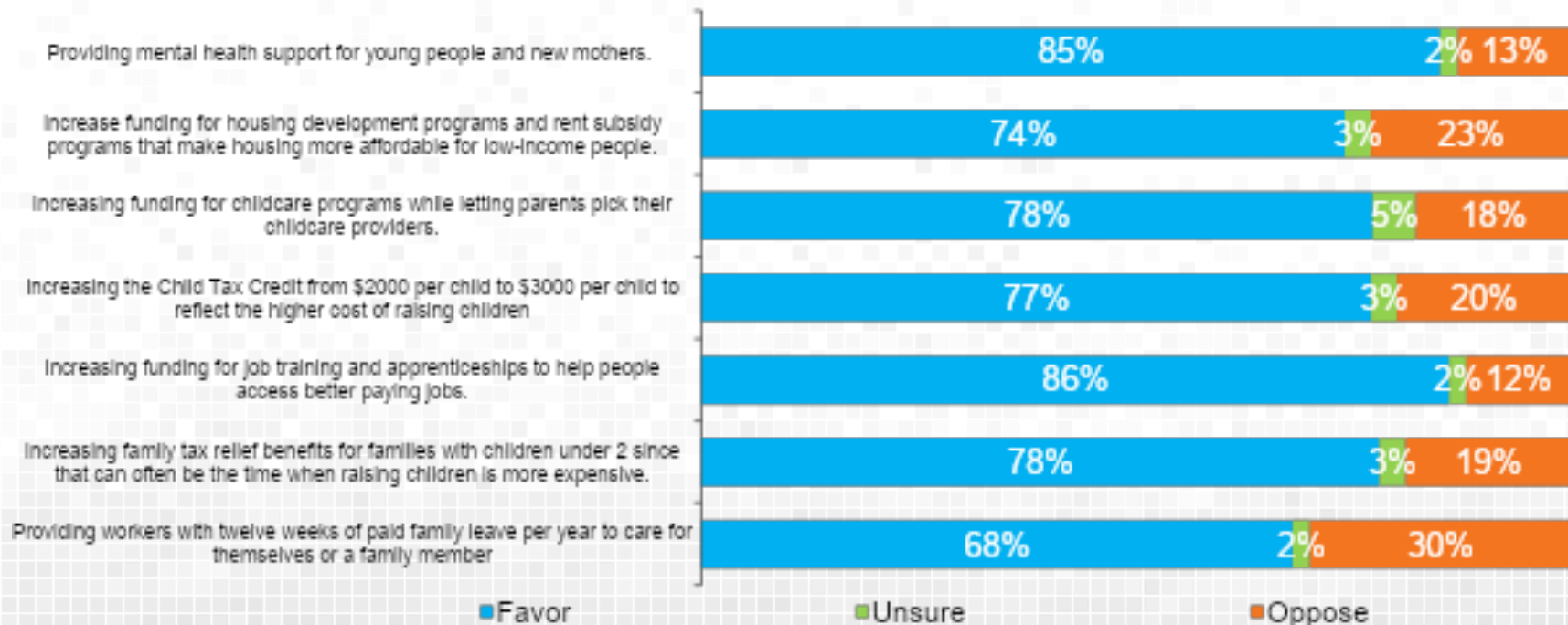
